**DESCRIPTION OF AN AMENDMENT IN THE NATURE OF  
A SUBSTITUTE TO THE PROVISIONS OF H.R. 4619, A BILL TO MAKE  
PERMANENT THE RULE ALLOWING CERTAIN TAX-FREE DISTRIBUTIONS  
FROM INDIVIDUAL RETIREMENT ACCOUNTS FOR CHARITABLE PURPOSES**

The Chairman's amendment in the nature of a substitute modifies H.R. 4619. The amendment provides that the bill may be cited by the short title, "Permanent IRA Charitable Contribution Act of 2014."
